CANCELLATION POLICY

There is a thirty (30) day cancellation policy if cancelling entire room block. Cancellations received after 60 days will result in a cancellation fee of first nights room and tax for all rooms.

For individuals a forty-eight (48) hour advance cancellation notice is required, or a one night's room and tax penalty will be assessed.

CHECK-IN/CHECK-OUT TIMES

Please advise your attendees to arrive after 4:00 p.m. (Monday through Thursday) or after 5:00 p.m. (Friday through Sunday) so rooms can be ready upon their arrival. Check out time is at noon. Anyone checking out after noon without prior approval of the Hotel may incur late charges. Late check-out approval is dependent on room availability and subject to the Hotel's business needs.
